#### **Overview**

MSMEs play a crucial role in providing large employment opportunities at comparatively lower capital cost and also encourage entrepreneurial activities in rural and backward areas.


Considering its importance, the Government of India (GOI) had during the last five years taken various measures for the MSME and has given suitable weightage to MSMEs in its special economic package announced in May 2020.

Further, the Union Minister Mr. Narayan Tatu Rane in one of the MSME Conclave organized by the Ministry of MSME in Guwahati on 18th November, 2021 said that the Centre will give emphasis on the development of Micro, Small, and Medium Enterprises (MSMEs) in the North East to ensure economic prosperity in the region and propel the sector's contribution to the country's Gross Domestic Product (GDP).

Currently, the sector consists of over 6 (six) crore units and employs over 11 (eleven) crore people. Its contribution to the country's GDP is 30%, and MSMEs account for over 49% for overall exports from India.
