And to deal with the tax procedures related to the administration, collection and enforcement of Tax by the Authority, separate Decree Law Federal Law No. (7) of 2017 on Tax procedures has been notified. The law provides for concept of "Tax Agency", audit by authorities, assessment, demand, administrative penalties, tax evasion, manner of claiming refund and other relevant aspects.

The VAT rules can be complex and taxable entities require careful planning to comply completely. Non-compliance with provisions of VAT Law and FTA guidelines can adversely impact organisations in multiple ways and lead to loss of reputation and prospective business.
